Ordinance No. 7.04

Amending Town of Wheatland Ordinance No. 7, entitled,
Intoxicating Liquors and Liquor Licensing

The Town Board of the Town of Wheatland pursuant to its authority under Sections 60.10(2)(c) and 125.17(3) Wis. Stats. does hereby amend the Town of Wheatland, Intoxicating Liquors and Liquor Licensing Ordinance and does ordain as follows:

1. Section 7.04 OPERATOR'S LICENSE is hereby repealed and recreated as follows:

7.04 OPERATOR'S LICENSE. No Premises may be open for business unless there is upon the Premises the licensee, the agent named in the license or permit if the licensee is a corporation or limited liability company, or some person who has an operator's license and who is responsible for the acts of all persons serving any Alcohol Beverages to customers. Application forms for an Operator's License may be obtained from the Town Clerk, and shall be filed not less than 45 days prior to the granting of such license. All applications for Operator's Licenses shall be filed with the Town Clerk and accompanied by an application fee set by resolution of the Town Board. All Operators' Licenses granted hereunder shall expire on June 30th of ~~each even numbered~~ year.

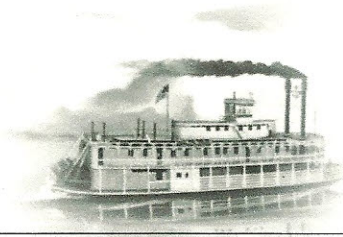

Amending Town of Wheatland Ordinance No. 2.06, entitled,
Town Plan Commission

The Town Board of the Town of Wheatland pursuant to its authority under Sections 60.10(2)(c) Wis. Stats. does hereby amend the Town of Wheatland, Town Plan Commission and does ordain as follows:

Section 2.06 (B) Establishment and Section 2.06 (C) Membership is hereby repealed and recreated as follows:

(B) *Establishment.* The Town Board, having been authorized by the Town meeting under sec. 60.10(2)(c), Wis. Stats., to exercise village powers, hereby exercises village powers under sec. 60.22(3), Wis. Stats., and establishes a **five (5) member** Plan Commission under secs. 61.35 and 62.23, Wis. Stats. The Plan Commission shall be considered the "Town Planning Agency" under secs. 236.02(13) and 236.45, Wis. Stats., which authorize, but do not require, Town adoption of a subdivision or other land division ordinance.

(C) *Membership.* The Plan Commission consists of one (1) member of the Town Board, who may be the Town Board Chairperson, and four **(4) citizen members**, who are not otherwise Town officials, and who shall be persons of recognized experience and qualifications.

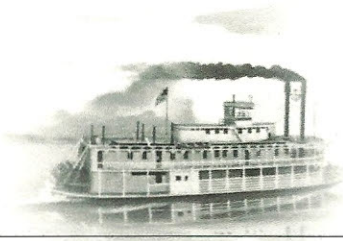

Amending Town of Wheatland Ordinance No. 5, entitled,
Building, Subdivision and Platting

The Town Board of the Town of Wheatland pursuant to its authority under Sections 60.10(2)(c) Wis. Stats. does hereby amend the Town of Wheatland, Building, Subdivision and Platting Ordinance and does ordain as follows:

Section 5.02(C) FIRE NUMBER is hereby repealed and recreated as follows:

5.02(C) If the Town Board determines that it is necessary to assign a new fire number, the town shall assign a fire number to the GPS location, and provide and install an approved post and fire number sign. ~~The property owner shall pay to the town of fee of \$50 for each new fire number.~~ New and or any replacement fire number signs will be of the land owner's expense. New sign fee will be \$50 and replacements will be the cost of materials.
