REGULAR MEETING **September 19th, 2018** **MINUTES**

The regular meeting of the Wheatland Town Board was called to order Chairman Tegen, with the Pledge of Allegiance. The Meeting was properly posted at the Community Center, the Redmound Store, the Recycling Center and the Town Website.

Present: Chairman Phil Tegen, Supervisor Jayne Ballwahn, Supervisor Donnie Stokke, Jr and Clerk Joann Schultz.. Treasurer Kelly Boardman was absent.

Motion by Ballwahn/second by Stokke to, "approve the August 16th, 2018 regular meeting minutes as presented." Motion carried.

Public comments: None

Supervisor Ballwahn indicated the insurance company of Riverside Farms turned down the insurance claim payment and denied all liability for the damage on Lawrence Ridge Rd. Town Board will discuss options with Town's attorney.

Mark Randa and Cindy Eisenman express their concern that Battle Ave was deeded over to the Township and it should be a private road deeded to that ridge Association. The Town Board was unaware of this and will check with Vernon County of when and who completed and signed this transfer.

Motion by Tegen/second by Stokke to, "pursue the process to change Battle Ave back to the Association on that ridge." Motion carried.

Patrolman McCumber reported: Patrolmen have been brush mowing roadsides, hauling ½" bit mix. Fabick Cat repaired the brakes and installed a new check valve-air dryer on the 140G grader, two tires will be replaced on the 5500 Truck, 2000 4800 Truck needs two new tires and a brake adjuster was purchased. Sealcoat will be completed the beginning of next week.

No Fire Department report

Financial reports were presented and reviewed by the Town Board. All accounts are reconciled and balanced. August income is \$92,221.92 and Expenses are \$59,764.73. Total cash on hand, in all funds, is \$302,321.48.

Motion by Stokke/second by Ballwahn to, "approve checks #22817-22847 and EFTPS & WT6 ACH's ." motioned carried.

Motion by Ballwahn/second by Stokke to, "transfer \$46,000 from Lansing Kerndt MM to Peoples Bank checking account." Motion carried.
