REGULAR MEETING **November 19, 2020** **MINUTES**

The regular meeting of the Wheatland Town Board was called to order Chairman Ballwahn, with the Pledge of Allegiance. The Meeting was properly posted at the Community Center, the Redmound Store, and the Recycling Center.

Present: Chairman Jayne Ballwahn, Supervisor Gloria Binger, Supervisor Doug Trussoni, Treasurer Kelly Boardman and Clerk Joann Schultz.

Motion by Binger/second by Trussoni to, “approved the October 22nd, 2020 regular meeting minutes as presented with striking out the repeated burn ordinance motion and indicate it was reviewed for the second time.” Motion carried.

Public comments: None

Patrolman McCumber reported. Patrolmen have been cleaning ditches, R.D. completed the fix of the wing walls, fixed the 96-4800 truck sander, installed two new lift cylinders in the 4800 trucks and checked gear boxes, plows are ready to be put on and the sanders are installed, 5500 truck brakes and pads have been replaced, will need to have the 4x4 drive serviced and replace the rear seals. Replaced first aid eye wash kit in the shop and we will need to purchase a dog kennel to cage all the aluminum cans in the recycling center. The Board discussed the removal of the accumulated metal pile in the recycling center. They discussed having an outside source remove it in a timely matter before the snow comes.

Motion by Trussoni/second by Binger to, “have Brent Johnson haul out the metal / steel scrap through the end of the 2020 year with an agreed 15% of the sale coming back to the Town & call him on an as needed basis for future removal.” Motion carried.

No Fire Department report.

Chairman Ballwahn reviewed for the third and last time the previously approved burn ordinance.

Treasurer Boardman presented the financial reports to the Town Board. All accounts are reconciled and balanced. Total cash on hand, in all funds as of this date are \$322,724.04.

Motion by Binger/second by Trussoni to, “accept financial reports as presented.” motioned carried.

Motion by Trussoni/second by Binger to, “transfer \$26,000.00 from People’s MM to People’s Checking account.” Motion carried.

Motion by Binger/second by Trussoni to, “approve checks #23732- #23771 including and WRS, EFTPS & WT6 ACH’s.” motioned carried.

Town Clerk handed out draft detail budget that would be reviewed at the upcoming budget/annual meeting.

Next regular meeting will be Thursday, December 17, 2020 at 4:30pm.

Motion by Trussoni /second by Binger to, “adjourn the meeting.” motion carried.
